## ORDER

This order amends Administrative Order No. 2007-215. Pursuant to Section 478.240 R.S.Mo. and applicable local rules, all circuit judges and associate circuit judges shall rotate Criminal and Domestic Violence after hours duty in 2008, as set forth on the attached schedule. The judge having duty will be responsible for the following matters, effective immediately:

- 1. Said judge shall be "on call" for evening, weekend and holiday domestic violence matters from 5:00 p.m. on the first Monday of his or her assigned week to 8:00 a.m. on the following Monday. Whenever the second Monday is a designated holiday, the judge remains "on call" until the next business day.
- 2. Said judge shall be on call for evening, weekend, and holiday criminal matters from 5:00 p.m. on Monday of his or her assigned week to 8:00 a.m. on the following Monday. However, whenever such Monday is a designated holiday, the judge remains on call until the next business day.
