
IN RE: AMENDED 2006 CRIMINAL AND DOMESTIC VIOLENCE AFTER

ADMINISTRATIVE ORDER NO: 2006- 7  
ORDER

This order amends Administrative Order No. 2005-185. Pursuant to Section 478.240 R.S.Mo. and applicable local rules, all circuit judges and associate circuit judges shall rotate Criminal and Domestic Violence after hours duty in 2006, as set forth on the attached schedule. The judge having duty will be responsible for the following matters, effective immediately:

1. Said judge shall be "on call" for evening, weekend and holiday domestic violence matters from 5:00 p.m. on the first Monday of his or her assigned week to 8:00 a.m. on the following Monday. Whenever the second Monday is a designated holiday, the judge remains "on call" until the next business day.
2. Said judge shall normally be responsible for criminal weekend and holiday duty from 5:00 p.m. on Friday of his or her designated week to 8:00 a.m. on the following Monday. However, whenever such Monday is a designated holiday, the judge remains responsible for criminal weekend and holiday duty until the next business day. In addition, whenever another weekday during a judge's assigned week is a designated holiday, the judge shall be responsible for criminal weekend and holiday duty from 5:00 p.m. on the day preceding the holiday to 8:00 a.m. on the next business day following the holiday.
