Pursuant to Missouri Statutes and applicable local rules, and as appointed by the Court en banc or a member thereof designated by law as the appointing authority, assignments for Commissioners of this Court for the period beginning June 29, 2018, through December 31, 2018, are as follows:

#### IT IS FURTHER ORDERED THAT:

- 1. Cases shall be scheduled for jury trial by the Circuit Judges in accordance with the attached 12-week cycles. The schedules may be deviated from only in accordance with local rule 6.2.
- 2. Cases identified by the County's Corrections Department, Office of Population Control, where the case is still in the initial stages up to and including being scheduled for circuit arraignment, but prior to being assigned to a division for trial, and the defendant is in custody, **may** be placed on the Population Control or Early Disposition Docket in Criminal "A". By the terms of this assignment order, these cases shall be temporarily transferred and assigned to Criminal "A". The Circuit Judge of Criminal "A" shall have the right to take action on the case, up to and including disposing of the case. However, also by the terms of this assignment order, if not disposed, the case shall be transferred / reassigned to the assigned judge previous to placement on such docket.
- 3. All cases filed pursuant to the Criminal Activity Forfeiture Act (Sections 513.600 through 513.651 and 195.140 R.S.Mo.), referred to herein as CAFA cases, shall be assigned to the Circuit Court Judge assigned to Criminal "A".
- 4. Driver cases, as referred to herein, shall include Petitions for Trial de Novo from Administrative Revocations or Suspensions, Applications for Hardship Driving Privilege, Applications for Hearing on Refusal to Submit to a Chemical Test (referred to herein as "Refusals"), and Petitions for Review. The Associate Circuit Judges of Divisions 26, 27, 29 and 31 shall hear those cases filed in Kansas City and the Associate Circuit Judges of Divisions 32 and 33 shall hear those cases filed in Independence.

- 5. Expungement Cases, as referred to herein, shall include Petitions for Expungement filed pursuant to Sections 610.123, 610.130, 610.140, or 610.145 R.S.Mo. The Associate Circuit Judges of Divisions 26, 27, 29 and 31 shall hear those cases filed in Kansas City and the Associate Circuit Judge of Division 33 shall hear those cases filed in Independence.
- 6. In accordance with Paragraph 1, Section 478.072 R.S.Mo., all Associate Circuit Judge uncontested civil matters, in which damages exceeding \$5000 are requested, shall be on the record and preserved by utilizing electronic, magnetic, mechanical sound, or video recording devices.
- 7. In accordance with Paragraph 1, Section 478.072 R.S.Mo., all Associate Circuit Judge contested civil matters shall be on the record and preserved by utilizing electronic, magnetic, mechanical sound, or video recording devices.
- 8. All Judges of this Circuit shall rotate evening, weekend, and holiday on-call duty to review domestic violence orders of protection and criminal matters pursuant to a weekly schedule established by administrative order.
- 9. The Family Court Commissioners shall rotate evening, weekend, and holiday on-call duty to review orders pursuant to Chapter 211 R.S.Mo. pursuant to a weekly schedule established by administrative order.
