Downtown courthouse closure update for hearings scheduled for  
Wednesday, February 13, 2019

The Jackson County Circuit Court continues its effort to change the locations of hearings scheduled at the downtown courthouse, 415 E. 12th Street, Kansas City. The building is presently closed as repairs are made due to a water line break. All other courthouses and court buildings are open.
