## The Warrant Recall Project

Log into a virtual Warrant Recall Walk-In Docket and the judge will cancel you warrant and give you a new court date possibly resolve cases that do not require a mandatory court hearing. **This is not for attorneys**. Attorneys please

use procedures found at <a href="www.kcmo.gov/court">www.kcmo.gov/court</a> under Information for Attorneys.

9 to 10:30 AM Mondays, Tuesdays, Wednesdays, Thursdays and Fridays. You Must log in before 10:30 AM. Dockets will lock at 10:30 AM. Late arrivals should return on the next available virtual walk-in docket.

## **Parking Fine Reduction Fridays**

Log into a virtual Parking Fine Reduction Docket and the City Prosecutor will reduce your parking fine in exchange for a plea of guilty. **This is not for attorneys**. **1:30 to 3 PM Fridays only** You Must log in before 3 PM. Dockets will lock at 3 PM. Late arrivals should return on the next available virtual parking fine reduction docket.

#### 20% off Past Due Fine Amount Days

Receive a 20% discount on fines if you pay your past due balance in full. **You MUST request the 20% discount in writing BEFORE paying by** Email to McPayment@kcmo.org; mail to Municipal Court Violations Bureau, 511 E. 11<sup>th</sup> Street, Kansas City, Missouri 64106 OR Drop box in the lobby of Municipal Court.

- You must include:
  - o The words "#ResolveIt" or "20% discount" in the email subject line or in your letter.
  - o Your full name, date of birth, valid phone number, mailing address and email address.
  - o Include your ticket numbers, if available.
- The Court will contact you with your discounted amount (80% of the fine amount plus court costs) and the instructions for making that payment in its entirety. Once that discounted amount is paid, the Court will credit the other 20% and close your case. The discount is not applied to restitution amounts.
  - You will not receive the 20% discount if you fail to contact the court before paying, fail to include your complete name, date of birth or valid contact information or if you do not pay the discounted amount given to you by midnight on March 31<sup>st</sup>.
- If you cannot pay your balance in full, even with the discount, you may request a payment plan or request to complete community service instead of paying a fine during #ResolveIt. Income guidelines may apply to community service requests.



## 20% off Past Due Fine Request Form

You MUST request the discount in advance, then pay entire discounted amount by March 31, 2021.

- You must include your full name, date of birth, valid phone number, mailing address and email address.
- Include your ticket numbers, if available.
- The Court will contact you with your discounted amount (80% of the fine amount plus court costs) and the instructions for making that payment in its entirety. Once that discounted amount is paid, the Court will credit the other 20% and close your case. Discount does not apply to restitution.

You will not receive the 20% discount if you fail to contact the court before paying, fail to include your complete name, date of birth or valid contact information or if you do not pay the discounted amount given to you by midnight on March 31<sup>st</sup>.

If you cannot pay your balance in full, even with the discount, you may request a payment plan or request to complete community service instead of paying a fine during #ResolveIt. Income guidelines may apply to community service requests.
