IT IS FURTHER ORDERED that all attorneys-in-fact must show a governmental issued picture identification card when executing a bond, must list the responsible surety on the face of each bond executed, and must attach a Power of Attorney to each such bond; and

IT IS FURTHER ORDERED that this order supercedes any Surety Qualification Order heretofore published:
