JUDGMENT OF TEMPORARY CHILD SUPPORT, [TEMPORARY  
MAINTENANCE/TEMPORARY ATTORNEY FEES AND TEMPORARY COSTS]**

Having reviewed the Application for Pendente Lite Orders and the Suggestions in Opposition thereto, the Court finds:

The Petition for Dissolution of Marriage/Legal Separation was filed on \_\_\_\_\_.

The amount of child support based on the Missouri Child Support Guidelines is unjust and inappropriate because of the medical expenses of the child/ren not paid by insurance.

\_\_\_\_\_ is without/has adequate means to meet his/her reasonable needs. \_\_\_\_\_ has sufficient resources to be required to contribute to \_\_\_\_\_'s support.

IT IS FURTHER ORDERED that \_\_\_\_\_ pay the temporary child support [and the temporary maintenance] by income assignment through the Court Administrator of Jackson County, Missouri as trustee for remittance to \_\_\_\_\_.
