IT IS HEREBY ORDERED, pursuant to Missouri Rules of Court 33.17 and 37.29, that the following individuals and companies have been approved for the purpose of signing various bail bonds as sureties and/or as attorneys-in-fact, within the Sixteenth Judicial Circuit of Missouri; and

IT IS FURTHER ORDERED that all attorneys-in-fact must show a governmental issued picture identification card when executing a bond, must list the responsible surety on the face of each bond executed, and must attach a Power of Attorney to each such bond; and

IT IS FURTHER ORDERED that this order supercedes any Surety Qualification/Disqualification Orders heretofore published:

INSURANCE QUALIFIED SURETIES
