**Different Expungements Available Through the Circuit Court**

<b>Expungements of Convictions 610.140</b>	<b>Expungement of Arrest Record 610.123</b>	<b>Expungement of Alcohol Related Driving Offenses 610.130 (Formerly 577.054)</b>	<b>Expungement of Records Resulting from Stolen or Mistaken Identity 610.145</b>
<p>1. You may seek expungement for a statutorily allowable offense in which you were arrested, pled guilty or were convicted by filing a petition;</p> <p>2. You must list all offenses that are to be expunged in the same petition;</p> <p>3. The offense(s) that are the subject of the expungement must have occurred in Missouri;</p> <p>4. The offense(s) must have been prosecuted in the County in which the expungement petition is filed;</p> <p>5. Any felony conviction must have been more than 7 years ago and any misdemeanor conviction must be more than 3 years ago, since the completion of imprisonment or any period of probation or parole;</p> <p>6. You must have paid all court ordered restitution;</p> <p>7. You cannot have been found guilty of or plead guilty to any other offense within the prescribed time frames listed above, (not including violations of the traffic regulations provided under chapters 304 and 307);</p> <p>8. You are entitled to not more than two misdemeanor and not more than one felony expungements in each Circuit Court. ( If the offenses, violations, or infractions were charged as counts in the same indictment or information or were committed as part of the same course of criminal conduct, the person may include all the related offenses, violations, and infractions in the petition.)</p> <p align="center"><b>Forms and Fees</b></p> <p>For Fees, please see the Court's Website or the Clerk</p>	<p>1. Any record of arrest may be expunged if the arrest was based on false information and;</p> <p>2. There was no probable cause at the time of the petition to expunge to believe the individual committed the offense and;</p> <p>3. No charges were pursued as a result of the arrest and;</p> <p>4. You have not had subsequent or prior misdemeanor or felony convictions and;</p> <p>5. You did not receive an SIS probation based on the offense you were arrested for or for any offense related to the arrest and;</p> <p>6. No civil action is pending relating to the arrest and;</p> <p>7. You must provide a fingerprint card and a copy of the record you are seeking to expunge.</p> <p align="center"><b>Forms and Fees</b></p> <p>For Fees, please see the Court's Website or the Clerk</p>	<p>1. Your case must be your first alcohol related driving offense;</p> <p>2. Your case must be a state misdemeanor, county or city ordinance violation;</p> <p>3. You could not have been licensed or operating a commercial vehicle at the time of the violation;</p> <p>4. You must not be in possession of a commercial drivers license;</p> <p>5. You must not have any alcohol related charges pending at the time of the expungement hearing;</p> <p>6. Your plea of guilty or conviction must have been at 10 years before your expungement application;</p> <p>7. Your petition must include all parties that may maintain records relating to your offense.</p> <p>8. You are only entitled to one expungement under the provisions of this statute.</p> <p align="center"><b>Forms and Fees</b></p> <p>For Fees, please see the Court's Website or the Clerk</p>	<p>1. Any record (misdemeanor or felony) resulting from another using your identifying information or due to mistaken identify may have records of your apprehension,</p> <p>2. There was no probable cause at the time of the petition to expunge to believe the individual committed the offense and;</p> <p>3. You file in court where charge was last pending, and;</p> <p>4. You provide notice to the prosecuting attorney, and;</p> <p>5. You submit your petition using the OSCA form.</p> <p>6. For purpose of this expungement, "mistaken identity" shall mean the erroneous arrest of a person for an offense as a result of misidentification by a witness or law enforcement, confusion on the part of a witness or law enforcement as to the identity of the person who committed the offense, misinformation provided to law enforcement as to the identity of the person who committed the offense, or some other mistake on the part of a witness or law enforcement as to the identity of the person who committed the offense.</p> <p align="center"><b>Forms and Fees</b></p> <p>For Fees, please see the Court's Website or the Clerk</p>
