- 7. Applicant is not named to act as Personal Representative. File refusal to qualify of named Personal Representative.
- 8. File renunciations of persons entitled to act as Personal Representative or request a hearing.
- 9. Filed more than one year after the date of death of the decedent. Please resolve.

10. Application does not include addresses for all parties. Please inform the Court in writing as to what steps

have been taken to locate the heirs/devisees.
