- 3. Proposed Guardian is a non-resident of Missouri. File Designation and Acceptance of Resident Agent. (Form 10020a). Utilize residential addresses. Corporate or law firm addresses are not acceptable for purposes of serving as resident agent.
- 4. Petition for Appointment of Guardian and Conservator (Form 10320) is missing.
- 5. Consent to Appointment by proposed guardian/conservator (Form 10194) is missing/incomplete. Note: The three persons who know the proposed guardian's whereabouts must live at separate addresses and have separate phone numbers from the proposed guardian and each other.
- 6. Information for Guardians and Conservators (Form 10194a) is missing/incomplete.
- 7. Information Regarding Proposed Ward (Form 10320a) is missing/incomplete.
- 8. Affidavit (Form 10320b) was not provided.

IN THE MATTER OF

- 9. The petition reflects that the whereabouts of the natural father/mother are unknown. Please file an appropriate pleading which fully complies with Supreme Court Rule 54.12(c) and Local Court Rule 21.10.
- 10. The petition reflects that the natural father/mother is deceased. Please file a copy of the deceased natural parent's Death Certificate.
- 11. Your pleadings indicate that a juvenile case involving the minor is pending. Please file a consent from a family court judicial officer regarding this action.
- 12. The required background screening of the nominated guardian and/or conservator, in accordance with §475.050.4, is missing/incomplete. Please file the background screening or file an affidavit detailing the reasons why said reports can't be obtained.<sup>1</sup> (Only required if the nominated guardian is not the minor's spouse, parent, or adult sibling).

(Only required if the nominated conservator is not the minor's spouse, parent, adult sibling, or the Public Administrator).
- 15. Corporate Surety Bond in the amount of \$\_\_\_\_ must be filed. (Bond amount may be set at the hearing.)

## Other:

- 18. The motion and proposed order for appointment of private process server that you submitted did not include the registration number for the current year. Please take the necessary steps.
- 19. You have requested Jackson County Civil Process to serve the respondent(s). Please submit \$36.00 per person to be served.
- 20. Either notarized consents of the natural parents <u>or</u> service by summons is required. If you wish to obtain service of process by Jackson County Civil Process, please submit \$36.00 per person to be served. If you wish to use a private process server, please file the appropriate motion and proposed order.
