**ADMINISTRATIVE ORDER 2020-087**

**ORDER APPOINTING PRIVATE PROCESS SERVERS  
FOR SERVICE AT THE JACKSON COUNTY DETENTION CENTER**

This order amends Administrative Order No. 2020-070.

**WHEREAS**, the existence and spread of the COVID-19 has resulted in the declaration of a world- wide pandemic; and

**WHEREAS**, it is appropriate and necessary to take action to reduce the possibility of exposure to COVID-19 and to reduce the spread of COVID-19 creating this emergency; and

**WHEREAS**, countless governmental entities and private businesses have implemented numerous immediate actions and modifications to their normal course of business; and

**WHEREAS**, one of the actions taken by Jackson County, Missouri is severely restricting access to the Jackson County Detention Center (JCDC). This restriction includes denying access by members of the staff of the Court's Department of Civil Process, thereby eliminating the ability of the Process Servers who normally serve process to individuals incarcerated in the JCDC from completing that service; and

**WHEREAS**, it is imperative to take steps to protect the health and safety of all employees of the 16<sup>th</sup> Judicial Circuit, as well as of individuals both working at and housed within the JCDC, while also balancing the rights of all said individuals and parties to litigation; and

**WHEREAS**, the unprecedented circumstances existing at this time warrant this administrative action; and

**WHEREAS**, the Director of the Department of Corrections for Jackson County Diana Turner has provided the Court with affidavits from seven (7) individual Corrections Officers for the JCDC who are qualified to serve process, and who would be available to serve process on individuals incarcerated in the JCDC during the pendency of the pandemic; and

**WHEREAS**, on this date, the Court sua sponte finds that Christopher M. Wolfe, Kiva L. Hill, Craig A. Braden, Michael R. Webb, Jason E. Hays, Rebecca A. White and Lemuel L. Smith are qualified to serve process in matters where service of process has been ordered and it is determined that the party to be served is incarcerated in the JCDC. Affidavits from each of these individuals containing the information required by Local Rule 4.9 and attesting to such qualifications are attached and incorporated as Exhibit A.

**IT IS THEREFORE ORDERED**, effective immediately and continuing through June 30, 2020, unless modified prior to such date, that Christopher M. Wolfe, Kiva L. Hill, Craig A. Braden, Michael R. Webb, Jason E. Hays, Rebecca A. White, and Lemuel L. Smith are hereby appointed as private process servers specifically and solely for the purpose of serving process, which would otherwise be served by members of the staff of the Court's Department of Civil Process, to parties incarcerated in the JCDC.


