**ORDER STAYING REVOCATION OF DRIVER LICENSE**  
**FOR FAILURE TO TAKE CHEMICAL TEST**  
**REQUIRING IGNITION INTERLOCK DEVICE**

Pursuant to a timely Petition for Hearing Under Section 577.041, RSMo, filed in this court on \_\_\_\_\_, the Court hereby orders the Director's revocation of Petitioner's driving privilege effective \_\_\_\_\_, be stayed until the hearing on this matter on \_\_\_\_\_.

As the petitioner has a prior DWI or Refusal, the court orders you to have an **ignition interlock device with camera** installed on any vehicle you operate and prohibits you from operating any vehicle unless it is equipped with said device.

You are responsible for all costs associated with the installation, maintenance, calibration, and removal of the device. You are also liable for the cost of replacement if the device is broken, destroyed or stolen. (Section 577.602.5 RSMo.)
