IT IS FURTHER ORDERED THAT:

- 1. Cases shall be scheduled for trial by the Circuit Judges in accordance with the attached 12-week cycles. The schedules may be deviated from only in accordance with local rule 6.2.
- 2. All cases filed pursuant to the Criminal Activity Forfeiture Act (Sections 513.600 through 513.651 and 195.140 R.S.Mo.), referred to herein as CAFA cases, shall be assigned to the Circuit Court Judge assigned to Criminal "A".
- 3. Driver cases, as referred to herein, shall include Petitions for Trial de Novo from Administrative Revocations or Suspensions, Applications for Hardship Driving Privilege, Applications for Hearing on Refusal to Submit to a Chemical Test, and Petitions for Review. The Associate Circuit Judges of Divisions 25, 26, 27 and 31 shall hear those cases filed in Kansas City and Division 32 shall hear cases filed in Independence.
- 4. In accordance with Paragraph 1, Section 478.072 R.S.Mo., all Associate Circuit Judge uncontested civil matters, in which damages exceeding \$5000 are requested, shall be on the record and preserved by utilizing electronic, magnetic, mechanical sound, or video recording devices.
- 5. In accordance with Paragraph 1, Section 478.072 R.S.Mo., all Associate Circuit Judge contested civil matters shall be on the record and preserved by utilizing electronic, magnetic, mechanical sound, or video recording devices.
- 6. All Judges of this Circuit shall rotate evening, weekend, and holiday on-call duty to review domestic violence orders of protection and criminal matters pursuant to a weekly schedule established by administrative order.
- 7. The Family Court Commissioners shall rotate evening, weekend, and holiday on-call duty to review orders pursuant to Chapter 211 R.S.Mo. pursuant to a weekly schedule established by administrative order.
