- 5. The required background screening of the nominated guardian and/or conservator, in accordance with §475.050.4, is missing/incomplete. Please file the background screening or file an affidavit detailing the reasons why said reports can't be obtained.<sup>1</sup> (Only required if the nominated guardian is not the respondent's spouse, parent, adult child, adult sibling, or the Public Administrator).
- 6. The required credit history report of the nominated conservator, in accordance with §475.050.4, is missing/incomplete. Please file the credit history report or file an affidavit detailing the reasons why said reports can't be obtained. (Only required if the nominated conservator is not the respondent's spouse, parent, adult child, adult sibling, or the Public Administrator).
- 7. Petition for Appointment of Guardian and Conservator (Form 10193) is missing.
- 8. Consent to Appointment by proposed guardian/conservator (Form 10194) is missing/incomplete. Note: The three persons who know the proposed guardian's whereabouts must live at separate addresses and have separate phone numbers from the proposed guardian and each other.
- 9. Information for Guardians and Conservators (Form 10194a) is missing/incomplete.
- 10. Information Regarding Proposed Ward (Form 10320a) is missing/incomplete.
